MANUFACTURER'S CERTIFICATE GENTEK VINYL WINDOW AND PATIO DOOR PRODUCTS

Gentek exterior windows and doors (a brand division of Gentek Building Products, Inc.) are manufactured by parent company Associated Materials Incorporated (AMI), headquartered at 3773 State Road, Cuyahoga Falls, Ohio 44223. ENERGY STAR® qualified windows and patio doors, meet or exceed the criteria established by the U.S. Department of Energy for each of the climate zones. Qualifying products meet ENERGY STAR 6.0 standards for the climate zone in which they are installed. Qualifying products are eligible for a tax credit of 10% of the cost of the qualifying windows to a maximum of \$200 per household and patio doors to a maximum of \$500 per household for purchases made from January 1, 2011 to December 31, 2016. Note: If a taxpayer has already claimed a tax credit of \$500 for purchases made in any previous year, they are ineligible for additional tax credits for any new purchases. The tax credit does not include installation costs.
